CHARACTERISTICS OF GEM

SPECIAL ARRANGEMENTS AND PRECAUTIONARY MEASURES FOR THE EXTRAORDINARY GENERAL MEETING

In view of the recent development of the COVID-19 pandemic and recent requirements for prevention and control of its spread, the Company will adopt the following special arrangements at the EGM to protect attending Shareholders, staff and other stakeholders from the risk of infection:

- (i) Compulsory body temperature checks will be conducted on every Shareholder, proxy and other attendee at the entrance of the EGM venue. Any person with a body temperature of over 37.5 degrees Celsius may be denied entry into the EGM venue or be required to leave the EGM venue;
- (ii) All Shareholders, proxies and other attendees are required to (a) complete and submit at the entrance of the EGM venue a declaration form confirming their names and contact details, and confirming that they have not travelled to, or to their best of knowledge had close contact with any person who has recently travelled to, any affected countries or areas outside of Hong Kong as per guidelines issued by the Hong Kong government at any time in the preceding 14 days; and (b) scan the “LeaveHomeSafe” venue QR code prior to entry into the EGM venue. Any person who does not comply with these requirements will be denied entry into the EGM venue or be required to leave the EGM venue;
- (iii) All Shareholders, proxies and other attendees are required to comply with the requirements of the “Vaccine Pass Direction” (as defined under the Prevention and Control of Disease (Vaccine Pass) Regulation (Chapter 599L of the Laws of Hong Kong)) prior to entry into the EGM venue;
- (iv) All Shareholders, proxies and other attendees are required to wear surgical face masks inside the EGM venue at all times, and to maintain a safe distance between seats;
- (v) No refreshments will be served, and there will be no corporate gifts; and
- (vi) Other measures may be required by the governmental authorities/EGM venue.

To the extent permitted under law, the Company reserves the right to deny entry to the EGM venue or require any person to leave the EGM venue in order to ensure the safety of the attendees at the EGM. In the interest of all stakeholders’ health and safety and consistent with recent COVID-19 guidelines for prevention and control, the Company reminds all Shareholders that physical attendance in person at the EGM is not necessary for the purpose of exercising voting rights. As an alternative, by using proxy forms with voting instructions inserted, Shareholders may appoint the Chairman of the EGM as their proxy to vote on the relevant resolutions at the EGM instead of attending the EGM in person.

The proxy form is attached to this circular. Alternatively, the proxy form can be downloaded from the Company's website. If you are not a registered Shareholder (if your Shares are held via banks, brokers, custodians or the Hong Kong Securities Clearing Company Limited), you should consult directly with your banks or brokers or custodians (as the case may be) to assist you in the appointment of proxy.

If Shareholders choosing not to attend the EGM in person have any questions about the relevant resolution, or about the Company or any matters for communication with the Board, they are welcome to contact the Company by email to **ir@shuionnc.com**. If considered appropriate by the Company at its absolute discretion, the questions will be answered.

Due to the constantly evolving COVID-19 pandemic situation, the Company may be required to change the EGM arrangements at short notice. Shareholders should check the websites of the Company and the Stock Exchange for future announcement(s) and updates on the EGM arrangements.

I. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information of the resolutions to be proposed, and if thought fit, to be approved at the EGM relating to the re-election of the retiring Director and the proposed adoption of the New Articles of Association.

II. PROPOSED RE-ELECTION OF RETIRING DIRECTOR

As at the Latest Practicable Date, the Board consisted of eight Directors, including four executive Directors, namely, Mr. Yik Tak Chi, Mr. Chung Kin Man, Ms. Chung Wai Man and Mr. Lui Chi Tat, one non-executive Director, namely, Mr. Lau Joseph Wan Pui and three independent non-executive Directors, namely, Mr. Lau Tai Chim, Mr. Wong Wai Ho and Mr. Chan Ching Sum Sam.

Pursuant to Article 83(3) of the Articles of Association, the Directors shall have the power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or as an addition to the existing Board. Any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of members after his appointment and be subject to re-election at such meeting.

Mr. Kwok Chi Shing resigned as an independent non-executive Director, the chairman of the Audit Committee and a member of the Remuneration Committee with effect from 15 August 2022. Mr. Chan Ching Sum Sam (陳錚森) (“**Mr. Chan**”) has been appointed as an independent non-executive Director, the chairman of the Audit Committee and a member of the Remuneration Committee to fill the casual vacancy due to the resignation of Mr. Kwok Chi Shing with effect from the same date. For details, please refer to the announcement of the Company dated 15 August 2022. Accordingly, Mr. Chan will retire at the EGM and, being eligible, will offer himself for re-election as an independent non-executive Director at the EGM.

The Nomination Committee has reviewed the composition of the Board, the confirmation and disclosure given by Mr. Chan, the qualifications, skills and experience, time commitment and contribution of Mr. Chan with reference to the nomination principles and criteria set out in the Company’s Board Diversity Policy and Nomination Policy and the independence of Mr. Chan. The Nomination Committee has recommended to the Board on re-election of Mr. Chan as an independent non-executive Director. The Nomination Committee has also assessed and reviewed Mr. Chan’s written confirmation of independence based on the independence criteria as set out in Rule 5.09 of the GEM Listing Rules and confirmed that Mr. Chan remained independent.

Details of the Director proposed to be re-elected at the EGM are set out in Appendix I to this circular in accordance with the relevant requirements of the GEM Listing Rules.

III. PROPOSED ADOPTION OF NEW ARTICLES OF ASSOCIATION

Reference is made to the announcement of the Company dated 4 November 2022 in relation to the Proposed Amendments and proposed adoption of the New Articles of Association.

LETTER FROM THE BOARD

In order to keep up with the latest legal and regulatory requirements under the applicable laws of the Cayman Islands and the GEM Listing Rules (including the amendments made to Appendix 3 to the GEM Listing Rules in relation to the adoption of a uniform set of core shareholder protection standards with effect from 1 January 2022), and to provide flexibility to the Company for conducting general meetings as a hybrid meeting or an electronic meeting where Shareholders may attend by electronic means in addition to as a physical meeting where Shareholders attend in person, the Board proposes that the Company amends the existing Articles of Association and adopt the New Articles of Association.

The Proposed Amendments also explicitly set out other related powers of the Board and the chairman of the general meetings, including making arrangements for attendance as well as ensuring the security and orderly conduct of such general meetings. Other house-keeping amendments to the existing Articles of Association are made to better align with the wordings in the applicable laws of the Cayman Islands and the GEM Listing Rules and the Proposed Amendments. The Board proposes that the Company adopts the New Articles of Association in substitution for, and to the exclusion of, the existing Articles of Association.

Details of the Proposed Amendments are set out in Appendix II to this circular.

The legal advisers to the Company as to Hong Kong laws and the Cayman Islands laws have respectively confirmed that the Proposed Amendments comply with the applicable requirements of the GEM Listing Rules and do not violate the laws of the Cayman Islands. The Company also confirms that there is nothing unusual in the Proposed Amendments from the perspective of a company listed on the Stock Exchange.

The Proposed Amendments are prepared in the English language and the Chinese translation is for reference only. In case there are any inconsistencies between the English version and the Chinese version of the Proposed Amendments, the English version shall prevail.

The Proposed Amendments and the proposed adoption of the New Articles of Association are subject to the approval of the Shareholders by way of a special resolution at the EGM and shall take effect on the date the relevant special resolution is approved at the EGM.

IV. RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the GEM Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

V. EXTRAORDINARY GENERAL MEETING

A notice convening the EGM to be held at Unit 09, 7/F., FTLife Tower, No.18 Sheung Yuet Road, Kowloon Bay, Kowloon, Hong Kong on Friday, 2 December 2022, at 10:00 a.m. is set out on pages EGM-1 to EGM-2 of this circular. At the EGM, resolutions will be proposed to approve the re-election of the retiring Director and the adoption of the New Articles of Association.

A form of proxy for use at the EGM is enclosed with this circular. Please complete and return the accompanying form of proxy in accordance with the instructions printed thereon and return it to the Company's share registrar and transfer office, Boardroom Share Registrars (HK) Limited, 2103B, 21/F, 148 Electric Road, North Point, Hong Kong and in any event no less than 48 hours before the time appointed for holding the EGM (i.e., no later than 10:00 a.m. on Wednesday, 30 November 2022) or any adjournment thereof. The Company reminds Shareholders who wish to exercise his/her/its voting rights that they may appoint the chairman of the EGM as their proxy to vote on the relevant resolutions at the EGM.

To the best of the knowledge, information and belief of the Directors, having made all reasonable enquiries, no Shareholder (or its/his/her close associates) had any material interest in any of the resolutions to be proposed at the EGM and will be required to abstain from voting at the EGM to approve the relevant resolutions.

VI. CLOSURE OF REGISTER OF MEMBERS

For the purposes of determining the Shareholders' eligibility to attend and vote at the EGM, the transfer books and register of members of the Company will be closed from Tuesday, 29 November 2022 to Friday, 2 December 2022, both days inclusive. During such period, no share transfers will be effected. In order to qualify for attending the EGM, all transfer documents, accompanied by the relevant share certificates, must be lodged with the office of the Hong Kong branch share registrar and transfer office of the Company, Boardroom Share Registrars (HK) Limited, at Room 2103B, 21/F., 148 Electric Road, North Point, Hong Kong for registration no later than 4:30 p.m. on Monday, 28 November 2022.

VII. VOTING PROCEDURES BY SHAREHOLDERS

Pursuant to Rule 17.47(4) of the GEM Listing Rules, all votes at the EGM will be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. Therefore, the chairman of the EGM will demand a poll for each and every resolution put forward at the EGM pursuant to the Articles of Association. An announcement on the poll vote results will be published by the Company after the EGM in the manner prescribed under Rule 17.47(5) of the GEM Listing Rules.

VIII. RECOMMENDATION

The Board considers that the proposed re-election of the retiring Director and the proposed adoption of the New Articles of Association are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Board recommends the Shareholders to vote in favour of all resolutions to be proposed at the EGM.

**APPENDIX I DETAILS OF DIRECTOR PROPOSED TO BE RE-ELECTED
AT THE EXTRAORDINARY GENERAL MEETING**

The particulars of the Director proposed for re-election at the EGM are set out as follows:

Mr. Chan Ching Sum Sam (陳錚森) (“Mr. Chan”), aged 40, was appointed as an independent non-executive Director on 15 August 2022. He is also the chairman of the Audit Committee and a member of the Remuneration Committee. Mr. Chan obtained a degree of Bachelor of Business Administration with Accounting from the Hong Kong Baptist University in November 2005, and a degree of Master of Science with Financial Analysis from The Hong Kong University of Science and Technology in November 2012. Mr. Chan has been a fellow member of the Hong Kong Institute of Certified Public Accountants since March 2017.

Mr. Chan has over 16 years of experience in the finance and accounting industry. He has extensive knowledge and experience in cross-border as well as domestic mergers and acquisitions transactions and capital market transactions including initial public offerings, takeovers and financial advisory.

Mr. Chan has served as an independent non-executive director of Satu Holdings Limited (舍圖控股有限公司), the shares of which are listed on GEM (stock code: 8392), since September 2017.

Mr. Chan has served as a head of mergers and acquisitions & ESG of Wai Chi Opto Technology Limited since September 2022, wholly owned subsidiary of Wai Chi Holdings Company Limited, the shares of which are listed on the Main Board of the Hong Kong Stock Exchange (stock code: 1305). From July 2022 to August 2022, Mr. Chan served as an executive director of Titan Financial Services Limited. From May 2020 to July 2022, Mr. Chan served as a head of mergers and acquisitions and an executive director of the corporate finance department for Eddid Capital Limited. From December 2017 to May 2020, he served as a director of First Shanghai Capital Limited. From February 2013 to February 2017, he served at Changjiang Securities Holdings (HK) Limited with his last position being senior vice president of the corporate finance department. From December 2010 to August 2012, he served as an investment banking analyst at Piper Jaffray Asia Limited. From July 2009 to December 2010, he was an accounting senior officer in the finance division worked at China Construction Bank Corporation, the shares of which are listed on the Main Board of the Stock Exchange (stock code: 0939). From March 2008 to July 2009, he worked at PricewaterhouseCoopers as senior associate in the assurance department. From September 2005 to March 2008, he worked at Ernst & Young as accountant in the assurance and advisory business services department.

Mr. Chan has entered into a letter of appointment with the Company for an initial fixed term of three years commencing from 15 August 2022, and extended thereafter for such period as the parties may agree provided that either party can at any time terminate the appointment by giving the other party not less than three months’ prior notice in writing. Pursuant to the Articles of Association, Mr. Chan is subject to retirement by rotation and re-election at the annual general meetings of the Company. The current director’s fee payable to Mr. Chan is HK\$180,000 per annum and shall be reviewed by the Remuneration Committee annually. The remuneration package of Mr. Chan is determined by reference to his duty, qualification and experience and the prevailing market benchmark.

Mr. Chan has confirmed that he meets the independence criteria set out in Rule 5.09 of the GEM Listing Rules.

Save as disclosed above, Mr. Chan: (i) does not hold any other major appointment or professional qualifications; (ii) does not have any relationship with any Directors, senior management, substantial shareholders or controlling shareholders of the Company (as respectively defined in the GEM Listing Rules); (iii) does not hold any other positions in the Group; and (iv) has not held any directorship in any public companies the securities of which are listed on any securities market in Hong Kong or overseas in the last three years.

As at the Latest Practicable Date, Mr. Chan did not have any interest in any Shares, underlying shares or debenture of the Company and/or its associated corporation within the meaning of Part XV of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Save as disclosed above, there are no other matters concerning Mr. Chan that need to be brought to the attention of the Shareholders nor is there any information relating to the re-election of Mr. Chan as an independent non-executive Director that is required to be disclosed pursuant to any of the requirements under Rules 17.50(2)(h) to (v) of the GEM Listing Rules.
